

# **CARQUINEZ PROJECT UPDATE**

### Two project DSA Increments

- Incr. 1: Site Work and Utilities
   Incr. 2: Main Building Construction

   Including Demolition & Final Site work
- Increment 1 DSA approved Oct. 4<sup>th</sup>
- Increment 2 in DSA
- Increment 2 DSA approval
   Anticipated: May 2019





### CARQUINEZ BUDGET UPDATE

#### Project Budget: \$31,807,737

- Leaves us with 5% Contingency
  - \$1,346,009
- This will be included in the final Guaranteed Maximum Price (GMP)
- GMP negotiated with selected Contractor/Developer
- Based upon their Subcontractor bids
- Contractor will be on Board to assist in cost estimate update





# **CONTRACTOR SELECTION UPDATE**

Lease-Leaseback selection process

- Best Value Determination
   After scoring five proposals
   Interviewing four teams
- C. Overaa & Co. determined to be Best Value for District
- Approval of Site and Facilities Leases
  - On Board's agenda tonight
- Award Pre-Construction Services
  - \$74,5000 for estimating, constructability reviews, value engineering, logistics planning

#### Focused Environmental Impact Report (EIR)


- Board certified the EIR at December meeting

### Environmental Review

- Ph. 1 Study identified areas of further action
- Dept. of Toxic Substances Control (DTSC) meeting identified solution to clearing southern portion of site
- District's environmental consultant will be conducting new round of sampling
  - Band Room, transformer, southern site area
- Amendment to Ph.1 Study
- Will move area of focus to north end of site—later phase of work





# STATE FUNDING UPDATE

#### **Carquinez Middle School**

- Seismic Mitigation Program
  - District will seek replacement funding
  - Cost of work over 50% of replacement value
- District has completed first two steps of process
  - Eligibility Evaluation—approved by DSA
  - Evaluation & Design Criteria Report completed, approved by DSA
- Application for funding may only be filed upon DSA approval of new building plans (Increment 2)







# STATE FUNDING UPDATE

### John Swett High School

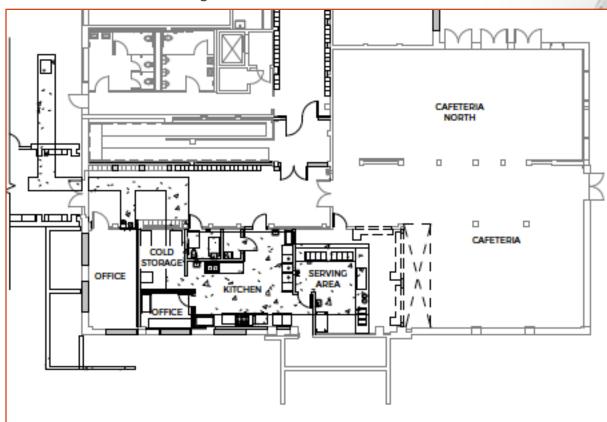
- Modernization Funding
- Eligibility has been updated with Office of Public School Construction (OPSC)
- 2018 Eligibility: **\$2,691,197**
- CA Dept. of Education approval required
  - In process, Preliminary approval received—additional documents filed
- DSA has approved plans
- OPSC funding application will be filed upon CDE approval




Ground Floor: Kitchen, Serving Renovations





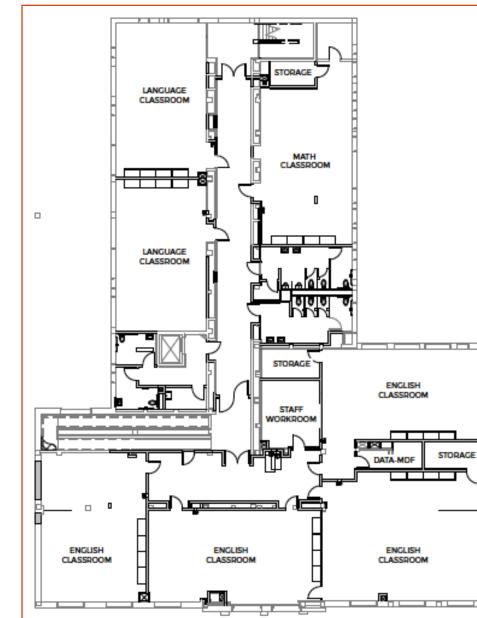

First Floor: Renovations Board Room, Office Areas, showing new location of Health Center





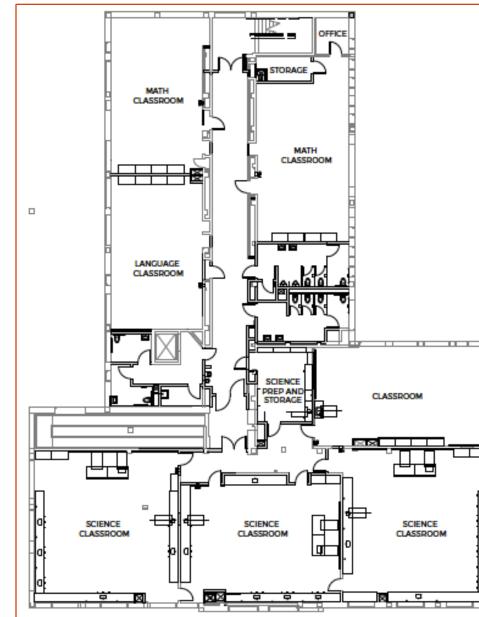

   \$15,580,500 including escalation for all phases
  - \$30,549 spent to date on Temporary Housing from main Construction budget
  - Budget balance for Construction: \$15,552,451
  - □ <u>Phase 1 Cost</u> \$ 8,774,000
  - Budget balance \$ 6,778,451
    - For Phase 2—Gym/Shops, Auditorium, West Cloister
